It sold for \$23.3 million, a new record for the Russian artist. The previous record for this work was \$23 million set in 2012. "Rigid and Curved" was first owned by the Solomon R Guggenheim Museum, which acquired it directly from the artist in 1936, a year after it was completed, according to Christie's.

A lively, colorful piece of geometric and organic shapes, it's been in the same private collection since 1964. AP
